1. Now This MOU Witnessed as Under:

- Rates for recyclables will be displayed time to time on recycle.
- Mother Theresa Institute of Pharmaceutical Education and Research, Kurnool will rise involves of the value to be received against the disposal of recyclable.
- The sustainability certificate for responsible disposal through the municipal corporation will be provided and the same can be accessed.
- Mother Theresa Institute of Pharmaceutical Education and Research, Kurnool is required to provide necessary entry and exit permissions included, but not restricted to gate-pass, other access formalities to use its space for loading of recyclable and man power movement during the time of pickup.

The project shall be valid and can be renewed for additional periods and quantities as per mutual agreement of Mother Theresa Institute of Pharmaceutical Education and Research, Kurnool and Municipal Corporation of Kurnool.

3. Indemnity:
